There was an informational in-service session- open to the public at 7:00 PM followed by the regular meeting.

Call to Order: Meeting called to order @ 7:40 PM by the President of the Board: Dorothy Morris.

Minutes of the Previous Meeting: A motion was offered by Mr. Bonnaffons, seconded by Ms Pastel to accept the June 26th, 2012 minutes- All were in favor of accepting the minutes. AYES 7: Morris, Kinney, Van Etten, Bonnaffons , Weyant, Reynolds, Pastel. Nays: 0. Absent: 1: Simpson.

Record Keeper's Report: Ms Van Etten reports no new activity.

Approval of vouchers to submit to Town Hall: Ms Van Etten made a motion to submit 18 signed vouchers to Town Hall. Motion seconded by Ms Pastel. All were in favor of submitting 18 vouchers to Town Hall. AYES 7: Morris, Kinney, Van Etten, Bonnaffons , Weyant, Reynolds, Pastel. Nays: 0. Absent: 1: Simpson.

Director's Report: presented by Ms. Bradshaw

- Buildings: Ms Bradshaw to work with Ms Potvin about getting a sign for the new ramp at Central Valley which will prohibit Skateboarding and bicycle riding on the ramp.
- Staff: Ms Bradshaw reports that Ms LaValle will be retiring end of March 2013. In addition, Kathleen Dwyer will be resigning August 10th. Ms Bradshaw will send a letter to the Town to request job posting to fill the 12 hour vacancy of Ms Dwyer.
- Accounting: Discussion, no action taken.
- Alarm: Ms Bradshaw to get a copy of the Town's insurance policy for the Library.

- Passes for Storm King Art Center: Motion made by Mr. Bonnaffons, seconded by Ms Morris for the Library to purchase pass for the Art Center. The motion was carried unanimously. AYES 7: Morris, Kinney, Van Etten, Bonnaffons , Weyant, Reynolds, Pastel. Nays: 0. Absent: 1: Simpson.
- Resignation of Ms Hood: A motion was made by Ms Reynolds for Ms Morris to speak with Mr. Burke about posting position vacated by the resignation of Ms Hood. Mr. Bonnaffons seconded the motion. All in favor: AYES 7: Morris, Kinney, Van Etten, Bonnaffons , Weyant, Reynolds, Pastel. Nays: 0. Absent: 1: Simpson.
- Fill Vice President vacancy: A motion was made by Ms Weyant and seconded by Ms Kinney for Mr. Bonnaffons to fill in as VP due to Ms Hood's resignation. Motion was carried: AYES 7: Morris, Kinney, Van Etten, Bonnaffons , Weyant, Reynolds, Pastel. Nays: 0. Absent: 1: Simpson.

Additional Items:

- Upholstery Update : Ms Morris presented her search results on finding an upholsterer for the Highland Mills furniture. Discussion and review by the Board. Ms Van Etten made a motion to accept the Ramos bid of: \$ 2,334.00- motion was seconded by Mr. Bonnaffons. The motion was carried unanimously. AYES 7: Morris, Kinney, Van Etten, Bonnaffons , Weyant, Reynolds, Pastel. Nays: 0. Absent: 1: Simpson.
